SUMMARY

The CCMUA conducted an internal audit of our Environmental Management System Communication & Outreach. The purpose was to examine the Authority's process and procedures for outreach and communication. This includes our environmental policy.

SUMMARY OF AUDIT FINDINGS

The Authority has several methods which are used to communicate our environmental policy and programs. These are; through the Camden Collaborative Initiative, the Authority's web site (ccmua.org), the organizations the Authority belongs to, internal meetings and memos, external meetings, mailings to our customers, the Green Ambassadors, the Camden PowerCorps and site tours. This audit has found that these efforts are sufficient for outreach and communication.

FINDINGS

On January 24, 2013, the Camden County Municipal Utilities Authority, with the support of City of Camden, Cooper's Ferry Partnership, New Jersey Department of Environmental Protection, and the United States Environmental Protection Agency, launched the Camden Collaborative Initiative. The Collaborative is building upon the success of environmental initiatives underway, made possible by the efforts and resources of multiple partners that have come together to address the complex environmental issues present in the City. The Camden Collaborative Initiative or CCI was formed to realize the many opportunities to maintain, restore, and enhance the environmental resources in the City of Camden.

The Authority staff meets frequent meetings with all groups of the Camden Collaborative Initiative. These meetings and discussions serve as a method to communicate our environmental programs. The meetings often lead to new projects with the CCI members or groups of members. The Authority supports these projects by providing staff to attending the meetings, providing meeting space. Authority staff and consultants usually work on the ensuing projects. The Authority also funds part or all of the costs of the many projects started through this process. Appendix A is a list of the CCI partner organizations.

The Authority web site documents the environmental work accomplished by our Authority often in partnership with the CCI members. The web site address is printed on every invoice mailed to each of the Authority's 160,000 customers. The web address is printed on letterhead, available through any web search and is updated frequently with additional information. The web site is frequently updated with new information and links. An abstract listing the environmental content of the web site is attached in Appendix B.

The Authority is a member of and communicates with the organizations listed in Appendix C. This communication and outreach can take several forms including working with other organization members to share ideas or, through the Authorities Executive Director/Chief Engineer, leading initiatives

that ultimately benefit the wastewater and stormwater community. Our Director is often asked to present at events held by the members on this list, CCI members and additional organizations.

Our Authority mails bills quarterly to all of our customers. The Authority is able to mail an insert will these bills. The majority of the inserts are about environmental topics. Often as part of outreach to our community, an insert for one of the CCI partners is mailed with our bill with no cost for our partner. Other inserts are designed by Authority Staff or CCI partners at the request of our Authority. Appendix D contains a schedule of the recent environmental insert topics.

Distributing the Authority's Environmental Policy and Mission Statement is an important aspect of our communications. The Authority web site has a page with this statement. The statement has been sent to all staff members each year and is given to all new employees.

Site tours are given on request. Several thousand people tour the Authority's treatment plant each year. The tours are scheduled in advance and are lead by our Director or other Authority staff. The sewer treatment process is explained to the tour groups. The tour usually begins at the model of our facility in the lobby of the Administration Building.

The Authority formed two educational programs for Camden youth. The Green Ambassador program began four (4) years ago. This program hires a group of Camden High School Students for five (5) weeks each summer. These students learn about environmental activities of our Authority and those of the CCI partners. The ambassadors pass this information on to other members of their community.

The Camden PowerCorps began during 2015. This is an AmeriCorps program supported by our Authority and Camden City. The members learn about the environmental activities of our Authority during their service. They maintain green infrastructure sites, County and City Parks and property.
