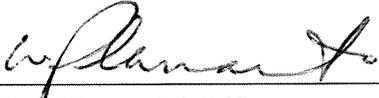

### AUTHORIZING EXECUTION OF AN AGREEMENT WITH THE UNITED STATES GEOLOGICAL SURVEY FOR THE RENEWAL OF STREAM MONITORING SERVICES FOR THE GREAT EGG HARBOR RIVER BASIN

R-19:7-88

**WHEREAS**, the CCMUA received approval from the New Jersey Department of Environmental Protection and the Pinelands Commission to eliminate the CCMUA's Sicklerville sewage treatment plant and convey the flow to the CCMUA's main plant in Camden City; and

**WHEREAS**, in accordance with the approval from the Pinelands Commission, we must address concerns regarding maintaining stream flow levels within the Great Egg Harbor River Basin; and

**WHEREAS**, the CCMUA entered into an agreement with the United States Geological Survey (USGS) via CCMUA Resolution #R-08:9-130, to provide stream monitoring services in the vicinity of the Sicklerville sewage treatment plant; and

**WHEREAS**, the CCMUA's Executive Director has negotiated an agreement with the USGS to monitor stream flow levels in the vicinity of the Sicklerville sewage treatment plant; and

**WHEREAS**, the USGS will be paid an annual fee of \$33,800 for the operation and maintenance of gaging stations plus an additional \$5,120 for the collection of discharge measurements at partial record sites; and

**WHEREAS**, sufficient monies are available and have been certified as being encumbered in accordance with N.J.A.C. 5:30-5.4 per attached Certification of Available Funds. The line item appropriation of the official budget adopted pursuant to the Local Budget Law which expenditure will be charged in accordance with the comptroller function is #0116 0485 0010; and

**NOW, THEREFORE, BE IT RESOLVED**, by the CCMUA Board of Commissioners that it authorizes execution of an agreement with the United States Geological Survey in the amount of \$38,920 to provide stream monitoring services in the Great Egg Harbor River Basin.

## **THE CAMDEN COUNTY MUNICIPAL UTILITIES AUTHORITY AUTHORIZING REJECTION OF BIDS RECEIVED FOR SPECIFICATION #19-14- HAULING AND BENEFICIAL REUSE OF DEWATERED SLUDGE CAKE AND AUTHORIZE RE-ADVERTISEMENT OF BIDS**

**#R-19:7-84**

**WHEREAS**, on July 2, 2019, the CCMUA opened bids for Specification #19-14 – Hauling and Beneficial Reuse of Dewatered Sludge Cake; and

**WHEREAS**, three bids were received by the Authority in response, one from United Trucking, one from Solid Waste Services dba JP Mascaro and one from Denali Water Solutions; and

**WHEREAS**, upon review of the bids received, it was determined that the apparent low bid submitted by United Trucking, Inc., included Exhibit Q, Acknowledgement of Receipt of Addenda. However, it was improperly filled out. The form indicates that no addendum has been issued when in fact there was an addendum issued. Therefore, this bid must be rejected. The next low bid received was from Solid Waste Services d/b/a JP Mascaro & Sons. This bid failed to include Exhibit Q, Acknowledgement of Receipt of Addenda. Therefore, this bid must also be rejected. The Final bid was received from Denali Water Solutions. Denali's bid does not fully disclose ownership in Exhibit E, Statement of Ownership Disclosure, while this is curable, the bid submitted by Denali is essentially a duplicate of the current Authority contract with Denali except the unit price is \$4.00 per ton higher in bid #19-14. Denali is not offering any additional capacity or disposal options for this higher unit pricing. As a result of the above, it is recommended that the Authority reject all bids received in response to bid #19-14 and re-advertise for bids; and



**WHEREAS**, accordingly the bid must be rejected.

**NOW, THEREFORE, BE IT RESOLVED** that the CCMUA Board of Commissioner's authorize rejection of all bids received for the above-referenced contract.

**BE IT FURTHER RESOLVED** that the staff authorize to re-advertise for bids.

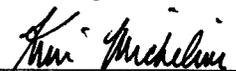

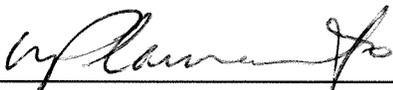

### AUTHORIZING A SETTLEMENT AGREEMENT WITH KOMLINE SANDERSON FOR REPAIR AND REPLACEMENT OF DAMAGED SLUDGE DRYER AGITATORS/SHAFTS

R-19:7-91

**Whereas**, the CCMUA entered into an agreement with Komline Sanderson for installation of three sludge drying facilities at the CCMUA's sewage treatment plant; and

**Whereas**, the dryers were completed and put into operation in 2010; and

**Whereas**, each of the three sludge dryers have two agitators, for a total of six agitators; and

**Whereas**, three of the six sludge dryer agitators have failed prematurely and need to be repaired/replaced; and

**Whereas**, in addition, independent of the agitator failures, each of the three dryers are due for their normal 10 year overhaul, which requires removal of the agitators anyway; and

**Whereas**, the CCMUA Executive Director/Chief Engineer has negotiated a settlement agreement with Komline Sanderson that calls for Komline to transport the agitators to their facility repair/replace them as necessary and return them to the CCMUA's plant for re-installation, at no cost to the CCMUA; and

**Whereas**, the CCMUA would pay for the normal overhaul of the dryers and the re-installation of the agitators; and

**Whereas**, sufficient monies are available for the cost of the 10 year overhaul (the CCMUA will not pay for the repair of the agitators as described above) and have been certified as being encumbered in accordance with N.J.A.C. 5:30-5.4 per the attached Certification of Available Funds. The line item appropriation of the official budget adopted pursuant to the Local Budget Law which the expenditure will be charged in accordance with the comptroller function is 0171 0495 0010.

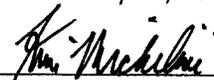

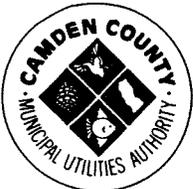

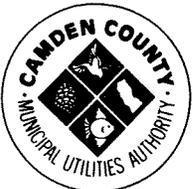

# Resolution of

## THE CAMDEN COUNTY MUNICIPAL UTILITIES AUTHORITY

### AUTHORIZING THAT THE AUTHORITY HOLD A CLOSED SESSION MEETING TO DISCUSS LEGAL MATTERS

#R-19:7-94

**WHEREAS**, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that a closed session meeting may be held for certain specified purposes when authorized by Resolution adopted by the governing body; and

**WHEREAS**, The Camden County Municipal Utilities Authority desires to discuss certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

\_\_\_\_\_ **Matters Required by Law to be Confidential:** Any matter which, by express provision of Federal Law or Statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.

\_\_\_\_\_ **Matters Where the Release of Information Would Impair the Right to Receive Funds:** Any matter in which the release of information would impair, restrict or otherwise adversely affect a right to receive funds from the Government of the United States and/or the State of New Jersey.

\_\_\_\_\_ **Matters Involving Individual Privacy:** Any material, the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodian, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance, and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including pending or anticipated litigation or contract negotiation legal matters, and it desires to do so in Closed Session.

\_\_\_\_\_ **Matters Relating to Collective Bargaining Agreements:** Any collective bargaining agreement or the terms and conditions which are proposed for inclusion in any collective bargaining agreement including the negotiation of the terms and conditions thereof with employees or representatives or employees of the public body.

\_\_\_\_\_ **Matters Relating to the Purchase, Lease or Acquisition of Real Property or the Investment of Public Funds:** Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.



\_\_\_\_\_ **Matters Relating to Public Safety and Property:** Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violation or possible violations of the law.

X  **Matters Relating to Litigation, Negotiations and the Attorney-Client Privilege:** Any pending or anticipated litigation or contract negotiations in which the public body is or may become a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.

\_\_\_\_\_ **Matters Relating to the Employment Relationship:** Any matter involving the employment, appointment, termination of employment, evaluation of the performance or promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public hearing.

\_\_\_\_\_ **Matters Relating to the Potential Imposition of a Penalty:** Any deliberations of a public body occurring after a public hearing or public portion of a meeting that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party.
