MINUTES OF THE REGULAR MEETING HELD ON DECEMBER 19, 2022

The Regular Meeting of The Camden County Municipal Utilities Authority was called to order by Chairman Michael G. Brennan at 6:03 P.M. and the meeting was held remotely via Zoom. On roll call, the Commissioners responded to their names as follows:

Chairman Brennan read the 'Chairperson's Commencement Statement' acknowledging that proper notice of this Regular Meeting setting forth the date, time and place of the meeting has been prominently posted on (1) a public bulletin board located in the lobby of the Administration building (2) mailed to the Courier-Post and Inquirer and (3) filed with the Clerk of Camden County as set forth in its annual schedule of meetings, in compliance with the Open Public Meetings Law.

ADOPTION OF MINUTES:

A motion was made by Commissioner Bresch and seconded by Commissioner Cutler to adopt the minutes of the Regular Meeting held on November 21, 2022. There being no question on the motion, a roll call vote was taken, and the Commissioners responded to their names as follows:

ADMINISTRATION REPORT:

I) ITEMS FOR DISCUSSION:

A) Administration:

Environmental Management System- December 2022 (oral report by staff)
 Mr. Schreiber noted that there were no outside (community) odor complaints in the past 30 days. However, there were three internal odor events. Internal odor events are those raised by CCMUA staff. All were investigated and resolved.

Mr. Schreiber updated the Board on three regulatory matters:

a) Environmental Justice Rule
The New Jersey Department of Environmental Protection (NJDEP) asked the CCMUA to hold a public hearing for the CCMUA's Title V (Air) permit. The staff has been working with its consultant, CDM Smith, on understanding what the CCMUA's obligations will be

once the rule takes effect. A public hearing will be held in 2023 with members of the community, including the Waterfront South neighborhood, explaining the permit requirements.

b) Dissolved Oxygen in the Delaware River

The United States Environmental Protection Agency (EPA) recently weighed in on this matter and have indicated that they will be involved in the rule making process, and, may do so on an expedited basis. If this occurs, the rule details, and the CCMUA's obligations, could go into effect in 12 months rather than the original 27 months planned. Mr. Schreiber added that, under the Delaware Basin River Commission (DRBC), the CCMUA is the 2nd largest discharger of ammonia to the Delaware River, beyond Philadelphia Water Department. Commissioner Swartz asked if there was a way to treat the ammonia before it enters the CCMUA's treatment process. Mr. Schreiber indicated that, to the best of his knowledge, there is no technology available to treat for ammonia at the discharge source. However, the CCMUA is looking into side-stream sewage treatment, which can treat a significant amount of ammonia in the sewage stream before it enters the CCMUA's treatment facility.

Mr. Gipson explained that ammonia is naturally occurring in sewage. The CCMUA treatment facility was designed to remove solids from the wastewater. In order to treat the ammonia in sewage, the CCMUA would need an advanced treatment system- or tertiary treatment. The CCMUA was not designed that way, so, as Mr. Schreiber mentioned, side stream sewage treatment is being considered which will remove a significant amount of ammonia before the sewage enters the CCMUA treatment plant.

c) Combined Sewer Overflow/Long Term Control Plan (LTCP) The NJ Department of Environmental Protection (NJDEP) have begun issuing the Combined Sewer Overflow/LTCP permits to several other wastewater treatment facilities. These permits will give the CCMUA a good idea of what the NJDEP will require of the CCMUA when it issues the CCMUA's permit in early 2023.

Mr. Zonis, Director of Engineer/Process Systems, advised the Board that the 2-year Newton Lake Dredging project will be substantially complete by year end. All dredging activities are complete and were completed within the contract price. The contractor is in the demobilization process, including cleaning and restoration of the site. Some restoration (plantings) will take place in the spring when the weather is more conducive to such activities.

Mr. Gipson, Director of Operations, updated the Board on the status of the oxygen generation plant. Approximately 15 months ago, the CCMUA's oxygen generation plant sieves failed. The sieves are a necessary component of plant's oxygen generation and, therefore, sewage treatment process. This failure cause difficulties in maintaining optimal process effluent as there was not sufficient oxygen for the treatment process. The CCMUA issued an emergency and, in November 2021, contracted with Air Products to replace the sieves. The final cost to replace the sieves is \$2.3 million (price was impacted by supply chain/COVID issues) and the time to receive and replace the sieves was 10-12 months. On November 28th of this year, the sieves arrived at the CCMUA and have since been installed, commissioned and are in operation. As a result of the sieve replacement, the plant's oxygen generation is back to full capacity, and the sewage treatment process is significantly improved.

1) Projects Update

Chairman Brennan asked for an explanation on the recent engineering services contracts awarded. Mr. Schreiber explained that these contracts are for:

- Planning and design (side stream treatment (ammonia) mentioned earlier
- Engineering Services for regulatory related issues including environmental justice, CSO/LTCP and Title V air permit)
- Construction management services for various capital improvement projects funded through the NJ Infrastructure Bank. He noted that the NJ infrastructure Bank requires that the CCMUA contract with a firm to perform construction management. However, the staff is considering self-funding these projects.

Regarding the pumping station roofs and doors project, Mr. Cornforth, Director of O&M, explained that the CCMUA's 35+ pump station roofs and doors are in need of upgrades as they are original (30+ years old) and have reached their useful life.

Commissioner MacFarlane noted that the plant's performance is back to normal (7ppm) which shows that the staff is doing a good job. The CCMUA's effluent, by permit, is 30ppm. So, the plant's performance at 7ppm far exceeds permit levels.

Furthermore, he added that the CCMUA's sewage treatment plant is nearing 50 years old, so continued investment in its process systems, upgrades, rehabilitation is to be expected. The staff needs to continue to plan for upgrades, emergency contingencies, and possible significant financial impacts

Mr. Schreiber noted that the plant received and processed a peak flow of 203 million gallons, which is about 100 million gallons more than it had ever received and treated. Mr. Cornforth noted that the recent completion of the expansion of the main plant allowed for this additional flow to be received without overflows.
