WHEREAS, two (2) sealed bids were opened on June 29, 2023 for the Rental and Cleaning of Uniforms and Floor Mats in accordance with Specification #23-20; and

WHEREAS, the apparent low bidder, Cintas, made several alterations to the Bid Specification document (the "Specification"), most notably stating that "'[f]ire retardant' shall be stricken and changed to 'flame resistant'" with respect to more than a dozen items listed in the Specification; and

WHEREAS, "fire retardant" fabric is treated with chemicals that extinguish fire on contact whereas "flame resistant" fabric is designed only to slow down ignition or combustion; and

WHEREAS, the CCMUA must procure uniforms made out of "fire retardant" fabric so that it can ensure the safety of its employees; and

WHEREAS, Cintas' modifications to the bid documents constitute the addition of separate terms and conditions to the Specification; and

WHEREAS, because Cintas' demand for the addition of separate terms and conditions operates as a material departure from the Specification, as well as deprives the Authority of assurance that Cintas would perform the contract in accordance with the Specification, Cintas' bid is materially defective and non-responsive under N.J.S.A. 40A:11-2(33); and

WHEREAS, the other bidder, American Wear, Inc. of East Orange, New Jersey, is the lowest responsible bidder that is able to meet the Specification requirements, with the following bid:

Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair, restrict or otherwise adversely affect a right to receive funds from the Government of the United States and/or the State of New Jersey. Authorizing the Executive Director to Amend the Application Submitted to the New Jersey
Department of Environmental Protection for Project S340640-33, Allowing for the
Procurement of a Contractor to Remove Grit and Trash from Approximately 30 Miles of the
Camden City Combined Sewer System

#### R-23:7-127

Whereas, the CCMUA has previously received authorization from the New Jersey Department of Environmental Protection ("NJDEP"") to award contract S340640-33, Bar Screen & Grit System Upgrades (the "Project"); and

Whereas, the Project is part of an overall strategy to allow more combined sewage into the Delaware No. 1 WPCF by increasing the surface areas of the Bar Screens; and

Whereas, the construction of the bar screen component of the Project is estimated to start in or around August 2024 due to the lead times of materials; and

Whereas, during periods of wet weather, the CCMUA routinely operates all three of its bar screens, but, during the Project, it will be necessary to take one bar screen out of service; and

Whereas, during times of high flow, the bar screens can become blinded by grit and trash from the Camden combined sewer system which then limits the amount of flow the CCMUA can receive from both the Camden combined sewer system and the County sanitary system, which makes the CCMUA system vulnerable to overflows upstream; and

Whereas, during times of high flow and/or when the bar screens are blinded, the Camden combined sewer system can relieve itself through the combined sewer overflows; and

Whereas, the County sanitary system is disallowed by permit from overflowing; and

Whereas, it has come to the attention of the CCMUA that there are large amounts of grit and trash in the Camden combined sewer system that have the ability to impact the CCMUA as described above; and



Whereas, it is in the interest of the CCMUA to remove the grit and trash from the Camden sewer system in an expedited manner so as to greatly reduce the potential for sanitary overflows in the County system; and

Whereas, the CCMUA is desirous of amending the Project to allow for the procurement of a contractor to expeditiously remove the grit and trash from the system; and

Whereas, the CCMUA is desirous of amending the Project application submitted to the NJDEP for S340640-33 to allow for this work to be funded in the same manner as the bar screen and grit system components.

Now Therefore Be It Resolved by the Camden County Municipal Utilities Authority Board of Commissioners that the CCMUA authorizes the Executive Director to amend the NJDEP application for S340640-33 to allow for the procurement of a contractor to remove grit and trash from approximately 30 miles of the Camden combined sewer system; and

Be It Further Resolved that the CCMUA authorizes the staff to develop and submit contract documents for review by the NJDEP so that a bid for grit and trash removal can be advertised as soon as possible.
